The new ICC models of contract for Consortia and Joint Ventures were launched a few months ago and the working group created within ICC is now revising the ICC model Turnkey Contract for Major Projects. FIDIC is completing the process of revision of its models and the work in progress has already stirred an intense debate. ICC Italia will host the next meeting of the ICC Working Group on Turnkey Contracts and has organized a seminar aimed at focusing the ongoing changes to the ICC contracts and introducing to the market the two brand new models for Consortia and Joint Ventures.

The workshop will focus on the distinctive features of the new models, with a comparison with the other forms employed in the industry. It is an invaluable opportunity for the Italian industry and all the professionals involved in the Construction and Engineering world to share experiences and contribute to the current work in progress.
